# **Course Description**:

The 1-mile, 3-mile, and 5-mile race courses are located in our wooded, upland forest and prairie. The 800-meter course is a groomed trail near the lowland forest and tall grass prairie.

# **Snowshoe Rental Fees**

Traditional wood snowshoes may be rented on race day for \$4/adult or \$3/kids. A limited number of Northern Lites snowshoes will also be available.

## **Race Fees**

Race fees include a long-sleeved race t-shirt, refreshments, a chili lunch, a Mosquito Hill goodie bag and admission to the Winter Family Fun Day event at 12:00 PM. Prizes will be awarded to top finishers. Entry fees are non-refundable.
